## **EU Aviation Emissions**

***“Member States shall ensure that each ... aircraft operator reports [carbon] emissions during each calendar year ... from 1 January 2010***

***In the event that an aircraft operator fails to comply ... [the] Member State may request ... an operating ban.”***

-- EU DIRECTIVE 2008/101/EC



# EU Emission Trading Scheme

- The EU has decided to reduce greenhouse gas (GHG) emissions from all flights to / from its territory during the years 2012-2020.
- Airlines will join the EU Emissions Trading Scheme (EU ETS), and will receive **emissions allowances**.
- To receive allowances, airlines must monitor emission data starting January 2010 and have this data verified by an accredited company.
- Beginning in 2012, airlines will have to surrender emission allowances for every ton of carbon they emit.

**Airlines that do not have enough allowances will have to buy them in the carbon market or face a €100 / ton fine.**

# Monitoring Plan Approval

- Airlines must receive EU approval for plans on how they will monitor the data by December 31 2009.\*
- These monitoring plans are of great importance to the airline:



**They directly impact the airline’s allowance allocation.**

**Unrealistic monitoring plans will force the airline into high compliance costs.**
